

## WVQHA Breeders Futurity Stallion Service Auction Agreement

In consideration of the mutual herein and other valuable consideration we the owner/owners of the stallion named above, sell, transfer, and assign the WVQHA, for its use in the SSA, a breeding for the year 20\_\_ to the above named stallion. It is expressly understood by all parties to this agreement that this breeding service is assignable only by the West Virginia Quarter Horse Association at its Stallion Service Auction, pursuant to the rules, terms and conditions set forth herein, and pursuant to such other rules as the WVQHA may have heretofore or may hereinafter adopt.

1. The WVQHA shall have the right to sell and assign the aforementioned breeding at its annual SSA and the proceeds there from belong solely to the WVQHA Breeders Futurity.
2. The owner of the mare who shall have purchased such breeding service shall pay WVQHA the bid price as follows. (a) Payment shall be by cash or check plus a \$25.00 office charge at time of purchase. No rights shall accrue till the check is honored by the bank. (b) No service shall be allowed until the bid is paid in full. Upon payment of the bid paid in full, the following rights, duties, and obligations accrue.
  - (1) The mare owner shall have the right to have the stallion service the mare to produce one live foal. If the mare should die or is vet certified as being unsound before birth of a foal the owner shall be entitled to a return privilege that season or the following year for a substitute mare in which case no live foal is warranted. A live foal is live if it stands and suckles. (2) If the stallion dies or becomes unfit for service and no live foal results, the mare owner shall receive credit for the bid at the next succeeding SSA. If not used, said bid shall become forfeited and no refund shall be due. (3) If the mare returns to race or performance training after being pronounced in foal, the live foal guarantee becomes null and void and all return privileges are cancelled.

The stallion owner will not be responsible for any disease, accident, sickness and/or death of mare or foal, and similarly the mare owner will not be responsible for such to the stallion.

All board, booking fees, shipping and chute fees and veterinary and miscellaneous fees are the responsibility of the mare owner. A Breeders Certificate shall be furnished the mare owner by the stallion owner upon payment of all expenses owed and the birth of a live foal.

The advertised breeding fee for the above stallion for 20\_\_ is \$\_\_\_\_\_ + \_\_\_\_\_.

The WVQHA and SSA shall not be responsible of accident, sickness or death to any stallion, mare and/or foal. The mare owner may assign his or her rights herein only with the consent of the WVQHA and the stallion owner.

The stallion owner whose breeding rights are sold at the SSA shall be entitled to a Free Entry in the Breeders Futurity and the mare owner who purchased the breeding shall also be entitled to a Free Entry in the year which the mare shall foal. The stallion owner may reserve the right to purchase his own breeding, thereby giving him one Free Entry for the mare and One Free Entry for the stallion (2 entries) in the WVQHA Breeders Futurity.
